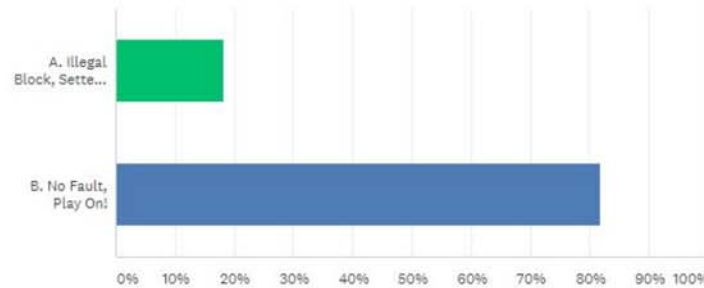
Assigner Reminders
