# TASO Membership Renewal DEADLINE Approaching.

The \$100 fee is the same as last year and includes your \$35 Continuing Education fee (which covers the cost of attending one or more of the following: Volleyball State Meeting, TASO Volleyball Regional Clinic or the Volleyball Online Clinic.) The **deadline to renew** and avoid a late fee is set to the first Tuesday in April – **April 6th, 2021**.

### Unsure if you have already renewed TASO???

Currently, only 55 current members have submitted their TASO dues. To verify whether or not a member is current on their TASO membership, there are two options: 1) attempt to submit a renewal on the TASO site - if already paid it will notify the member, 2) in Arbiter, go to Profile and then Custom Fields - members who have paid will show "Yes" in the TASO membership field.
