To verify whether or not a member is current on their TASO membership, there are two options: 1) attempt to submit a renewal on the TASO site - if already paid it will notify the member, 2) in Arbiter, go to Profile and then Custom Fields - members who have paid will show "Yes" in the TASO membership field.

#### 2020 Training/Meeting Requirements - Simplified!

By member's request, the meeting requirements have been simplified for 2020. <u>All returning members</u> are required to attend scrimmages and 5 total meetings/training sessions:

- 3 hours of scrimmages on August 7th or 8th (Possible scrimmage credit for those who exceed 3 hours)
- 1 ALR Session of the 3 available (highlighted in blue). Highly recommended to attend in May or June.
- 4 other sessions (of the 10 available) of your choosing (highlighted in orange and yes, including attendance at the state meeting)
- ➤ Returning members who do not attend a minimum of 3 hours of scrimmages and do not notify their ALR prior to May 1st will be subject to being assigned after all other eligible officials during the regular and post-season.
- ➤ Please plan accordingly to complete your required training early there will not be any additional sessions added as "make-ups".
- ➤ Members should attend one of the first two ALR Meetings. Members will not be "excused" for missing meetings.
- ➤ Members who have attended 3 hours of scrimmages, an ALR session and 4 other sessions by September 16th will be eligible for playoffs.

If you are a new official with in the last 3 years, you may want to attend more training sessions. Mentors who attend the Mentors Meeting and members of the training team who attend the Train the Trainer or assist with presentations at the intermediate or advanced clinics will receive credit toward their 5 meeting requirements. ACV will be moving toward paperless pay sheets in 2020. You will no longer need to print and take pay sheets to your matches. Schools will have the ability to print their own pay sheets for this season from Arbiter (they may ask you to sign it or another form to verify your attendance). We are encouraging all schools to use Arbiter Pay, as this will alleviate the need to submit a W9 as well since Arbiter keeps that information. If a school needs a W9 for an official (and does not use Arbiter Pay) then we will deal with that after the fact.

Availability to officials will be sent out in April after schools have a chance to receive the above notification. This will allow us to note which schools will have chosen to use Arbiter Pay.
