## **TASO Volleyball Division Elections**



The TASO Volleyball Division will be conducting elections for ***President, Vice President, and District Directors*** in Districts 1, 3, 5, 7, 9, 11 and 13 this year.

To serve as President or Vice President, a member must have been a member in good standing of TASO-Volleyball for the preceding 5 years prior to their nomination & must have served on the Board of Directors of TASO-Volleyball for at least one term.

To hold the office of District Director, a member must be a member in good standing of TASO-Volleyball for the preceding 3 years prior to their declaration to run for office & must submit a letter in writing/email from their home TASO-Volleyball chapter board (volleyball@taso.org) verifying status of membership.

If any Active Volleyball Members meet these requirements & would like to run for a position, you must submit a Candidate Profile, available in the Volleyball Member's Portal, and submit it to the State office (volleyball@taso.org) by October 1, 2023.

## What's the Call?

A tipped ball close to the net was saved by the libero who came charging from the back. Her momentum carried her forward causing her to completely cross the centerline. The area she crossed was outside of the antenna/sideline but inside the pole standard on the R2's side while never contacting the net, the court or interfering with any players on the other team. She then turned left, went around the pole standard and entered the court back on her side.

- A. Legal - no fault - play on.
- B. Illegal - centerline violation.
