It is possible that the site may change at the last minute. Click on the site name within Arbiter, found under the heading "SITE", to check for directions/address. All officials are strongly encouraged to have communication with Janiece prior to declining a match. Per ACV Policy, "members will be assessed a \$5 fee per declined match beginning with the second and any subsequent unaccepted/declined matches."

# Communication

Please take time to communicate with your co-official the prior week before the assigned match. It does not matter who reaches out first, be it the R1 or R2. Confirm the date and location, especially your estimated arrival time. Please take time to respond to emails/texts from your co-official promptly.

As you may recall, some schools did not even have volleyball teams last season so those 8th grade teams may be just as lost as the 7th grade teams.
